#### **NEW ACCOUNTS**

To open a new account to purchase with a credit card, the following is required: *TADA Application* form, completed, signed by returned by email, mail or via FAX.

#### \*Signed resale certificate required for all CA applicants

To open a new account and establish a *Credit Line*, the following is required: *TADA Application*, completed, signed and returned by email, mail or via FAX.

#### \*Signed resale certificate required for all CA applicants

Acceptance and establishment of a new account is at the discretion of both the Sales and Credit Departments. Tamiya America, Inc. reserves the right to refuse any application/order placed by any entity.

#### **PRICING**

Prices are per most current Price List or advertised special, offered at the time of the order. Prices are subject to change, but you will be notified in writing prior to shipping.

#### **ORDERS**

Orders will be accepted by telephone, mail, e-mail, via FAX or through <a href="www.tamiyausa.com">www.tamiyausa.com</a>. All products must be purchased in multiples of minimum quantities as set forth on the price list, or according to any special program.

### **BACK ORDERS**

Back orders for credit line customers will be shipped upon availability of product.

#### **FREIGHT**

## Tamiya America, Inc. does not ship C.O.D.

All shipments will be made F.O.B. California warehouse via best method as determined by Tamiya America, Inc., considering price and delivery time. Requests for expedited shipments may be accepted. The customer will be charged actual freight for expedited shipping.

#### **CLAIMS**

Claims for short shipment or incorrect items must be made within 7 days of receipt of goods. Claims for damaged items (including concealed damage) from shipment must be made within 7 days directly to Tamiya America.

#### **RETURNS**

Returned goods cannot be accepted without prior authorization from Tamiya America Dealer Access. Please call for a return authorization number. Authorization will be given for goods that are:

- □ Shipped in error
- Duplicate shipments
- □ Factory defects

Authorization will be given only if made within 7 days of receipt (excluding defective product) of goods. The return authorization number must be clearly visible on the outside of carton/package or delivery will be refused. A call tag may be issued for returns and return shipping charges will be reimbursed with a copy of shipping receipt.
